CONSENT ORDER

**IN THE MATTER OF:
LUANN H. STILLER
RESPIRATORY CARE LICENSE #1984**

WHEREAS the North Carolina Respiratory Care Board (the "Board") is charged with the administration of The Respiratory Care Practice Act, codified in the North Carolina General Statutes at G.S. 90-646 et Seq. (the "Act"); and

WHEREAS the Licensee was found allowing an unlicensed individual, under her supervision, to practice Respiratory Care in North Carolina in violation of G.S. 90.659(a)(4)c and G.S. 90.661(4); and

WHEREAS the Board conducted an investigation pursuant to G.S. 90-652 (5) into the activities of the Licensee to determine if she has violated, is violating, or is about to violate any provisions of the Act; and

WHEREAS the RCP license of Nathaniel Wilson expired at midnight on August 26, 2005; and

WHEREAS the Licensee allowed Nathaniel Wilson, RCP # 2144, to work with an expired license between the dates of August 27, 2005 to August 29, 2005; and

WHEREAS on January 11, 2006, the Investigation and Informal Settlement Committee of the Board, acting pursuant to 21 NCAC 61.0203, conducted an interview of the Licensee to determine the qualifications of the Licensee; and

WHEREAS the Board met on January 12, 2006 and determined to issue a Consent Order to the Licensee; and

WHEREAS the Licensee agrees to the entry of this Consent Order, and voluntarily agrees to waive any rights to a hearing upon entry of this Consent Order, and waives the right to seek judicial review or otherwise challenge or contest the validity of this Consent Order;

AND WHEREAS upon the entry of this Consent Order, this matter will be resolved with the express understanding that the Licensee will comply with all of the terms contained herein.

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

LuAnn H. Stiller shall continue to comply with the Act, the Board's Rules, and the Board's interpretation of those rules.

LuAnn H. Stiller agrees to the issuance of a Board Reprimand for her violations of the Act.

LuAnn H. Stiller agrees to pay to the Board before her next renewal date, August 22, 2006, the sum of \$250.00 for Civil Penalties which are authorized by G.S. 90-666(a) and 21 NCAC 61.0309 (d)(1) and the sum of \$100.00 to pay the cost of disciplinary action as authorized by G.S. 90-666(d).

LuAnn H. Stiller agrees to provide the Board a formal Plan of Correction which documents the steps she and the facility, in which she practices, have taken to correct this incident and to keep the incident from reoccurring. The Licensee agrees to complete the Plan of Correction and return the plan to the Board on or before February 15, 2006. The Plan of Correction must include the Licensee's signature and the signature of either the Human Resources Director or facility administrator.

LuAnn H. Stiller shall continue to comply with the Act, the Board's Rules, and the Board's published interpretation of those rules.


Entry of this Consent Order is without prejudice to the right of the Board to take any administrative or judicial action against Licensee to enforce this Consent Order if the Board determines that LuAnn H. Stiller is not fully complying with any term or condition stated herein.

This Consent Order shall become final when accepted by LuAnn H. Stiller and entered by the Board based on execution of the Consent Order by its Executive Director.

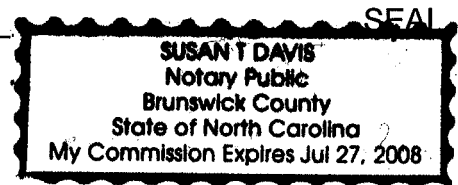


