CONSENT ORDER

**IN THE MATTER OF:
DONICA L. LANEY
RESPIRATORY CARE LICENSE #2728**

WHEREAS the North Carolina Respiratory Care Board (the "Board") is charged with the administration of The Respiratory Care Practice Act, codified in the North Carolina General Statutes at G.S. 90-646 et. seq. (the "Act"); and

WHEREAS on or about September 18, 2002, the Board issued a license to practice respiratory care to Ms. Donica L. Laney ("Licensee"), license number 2728; and

WHEREAS the Board received a complaint on March 14, 2006 from Carolinas Medical Center-Union, informing the Board that the Licensee had falsified respiratory care records by entering false values on a arterial blood gas record; and

WHEREAS the Board conducted an investigation pursuant to G.S. 90-652 (5) into the activities of the Licensee to determine if she has violated, is violating, or is about to violate any provisions of the Act; and

WHEREAS on July 12, 2006, the Investigation and Informal Settlement Committee of the Board, acting pursuant to 21 NCAC 61.0203, conducted an interview of the Licensee; and

WHEREAS the Board met on July 13, 2006 and determined to issue a Consent Order to the Licensee; and

WHEREAS the Licensee agrees to the entry of this Consent Order, and voluntarily agrees to waive any rights to a hearing upon entry of this Consent Order, and waives the right to seek judicial review or otherwise challenge or contest the validity of this Consent Order;

AND WHEREAS upon the entry of this Consent Order, this matter will be resolved with the express understanding that the Licensee will comply with all of the terms contained herein.

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

The Licensee agrees to the Suspension of her Respiratory Care Practitioner license for a period of 30 days. The Suspension Order shall be stayed for a period of 12 months.

The Licensee shall cause her immediate Respiratory Care supervisor to submit written quarterly reports to the Board, which shall be submitted by the 15th day of the 4 quarters following the signature of this Consent Order. Each such written report shall document the Licensee's performance in the delivery of Respiratory Care, and detail any concerns of the supervisor about the Licensee's practice of Respiratory Care.

The Licensee agrees to pay to the Board, within 90 days from the date of signature of the consent order, the sum of \$250.00 for Civil Penalties which are authorized by G.S. 90-666(a) and 21 NCAC 61.0309 (d)(1) and the sum of \$100.00 to pay the cost of disciplinary action as authorized by G.S. 90-666(d).

The Licensee shall continue to comply with the Act, the Board's Rules, and the Board's published interpretation of those rules.

Entry of this Consent Order is without prejudice to the right of the Board to take any administrative or judicial action against Licensee to enforce this Consent Order if the Board determines that the Licensee is not fully complying with any term or condition stated herein.

This Consent Order shall become final when accepted by the Licensee and entered by the Board based on execution of the Consent Order by its Executive Director.
