CONSENT ORDER

**IN THE MATTER OF:
SALLIE N. CARROLL
RESPIRATORY CARE LICENSE #2854**

WHEREAS the North Carolina Respiratory Care Board (the "Board") is charged with the administration of The Respiratory Care Practice Act, codified in the North Carolina General Statutes at G.S. 90-646 et Seq. (the "Act"); and

WHEREAS the Licensee was found practicing Respiratory Care in North Carolina with a Lapsed Respiratory Care Practitioner license in violation of G.S. 90.659(a)(1) c and G.S. 90.661(1)(2)(3) and (4), and

WHEREAS the Board conducted an investigation pursuant to G.S. 90-652 (5) into the activities of Licensee to determine if she has violated, is violating, or is about to violate any provisions of the Act; and

WHEREAS at midnight on September 27, 2004 the RCP license issued to the Licensee expired, and

WHEREAS the Board staff on October 27, 2004 was informed by the Licensee that she had practiced Respiratory Care during the time her license was lapsed at Betsy Johnson Regional Hospital, Dunn, NC, and

WHEREAS Board policy authorizes the Executive Director to issue a Reprimand to individuals found practicing Respiratory Care with a lapsed license within one (1) year of the expiration date of the license, and

WHEREAS Licensee agrees to the entry of this Consent Order, and voluntarily agrees to waive any rights to a hearing upon entry of this Consent Order, and waives the right to seek judicial review or otherwise challenge or contest the validity of this Consent Order,

AND WHEREAS upon the entry of this Consent Order, this matter will be resolved with the express understanding that the Licensee will comply with all of the terms contained herein.

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

Licensee shall continue to comply with the Act, the Board's Rules, and the Board's interpretation of those rules.

Licensee agrees to the issuance of a Board Reprimand for her violations of the Act.

Licensee agrees to pay to the Board within 90 days from the date of signature of the consent order, the sum of \$250.00 for Civil Penalties authorized by G.S. 90-666(a) and 21 NCAC 61.0309 (d)(1).

Licensee agrees to pay to the Board within 90 days from the date of signature of the consent order, the sum of \$50.00 for Disciplinary Costs authorized by G.S. 90-666(d) and 21 NCAC 61.0310 (e).

Entry of this Consent Order by the Board is without prejudice to the right of the Board to take any administrative action against Licensee to enforce this Consent Order if the Board determines that Licensee is not fully complying with any term or condition stated herein; and,

This Consent Order shall become final when accepted by the Licensee and entered by the Board based on the execution by its Executive Director.


